#### Wheelie Bins join campaign to slow speeding drivers

Wheelie bins in the Parish have become the latest tool to remind drivers to stick to the speed limit.

Residents are concerned about vehicles driving above the 30mph speed limit in Pepper Street and Northwood. Using an idea first used by police in Staffordshire, the Parish Council recently handed out large 30mph weatherproof stickers to be

stuck onto Pepper Street residents' green and black wheelie bins. Councillors hope that this will make a big visual impact on bin days to give a nudge to drivers to pay closer attention to their speedometers!

The stickers were provided by Shropshire Council and Parish Councillors will soon be visiting other 30mph speed limit areas!



# New Right of Way in Tilley Village



In 2010 Wem Rural Parish Council made a request to Shropshire Council to claim a footpath in Tilley Village as a public Right of Way to be added to the Definitive Map of Shropshire. Local people have used this path for more than 40 years as a circular route but part of it had never been formally claimed as a Right of Way. Councillors worked with residents to fill in User Evidence

forms provided by the Countryside Access Team and finally on 17th February 2011 Shropshire Council issued a Notice of Modification Order to add the footpath.

# CAR PARKING CHARGES

Despite fierce local opposition Shropshire Council's new parking strategy was approved on 22 December. Martin Taylor-Smith, Shropshire Council's Cabinet member for Transport and IT, said: "Through extensive consultation we have shaped this strategy to reflect the views of local people and businesses." Although not all of Wem Town and Wem Rural residents' opinions have been taken on board, we have gained a small concession in that the first hour in the High Street/Leek Street car park will be free.

From April 2011, car park charges are: High Street/Leek Street - first hour free, 10p for up to 2 hours and £1.80 for up to 10 hours. Mill Street - 10p for up to 2 hours and £1.80 for up to 10 hours. There is no free period.

Charges will apply everyday, including bank and public holidays between the hours of 8am - 6pm. There is no free parking for Blue Badge holders.

# Notice board for Tilley

One of the duties of the Parish Council is to publish legal notices including the meeting agendas in a public place so that parishioners have the chance to see what will be discussed. At the moment the Parish Council uses the notice boards at Edstaston Village Hall, Quina Brook, inside Coton Oaks, Newtown School, Edinburgh House Wem .....and the telegraph pole outside the Raven at Tilley (technically illegally).

The Parish Council has now purchased a second hand notice board and are looking for suggestions for a good home for it in Tilley. The notice board has two lockable doors. One side will be for Parish Council use but the other could be for the use of the community. ## **Annual Parish Meeting**

#### An informative update on Parish Matters

This year's Annual Parish Meeting was held two months earlier than normal on Tuesday 15 March. This was primarily to give the Parish Plan Steering Group the opportunity to give an update on their work and explain the next stage: the completion of a questionnaire by residents (see opposite).

The Chair of the Parish Council, Richard Powell, opened the meeting with his report on the Parish Council. Because this has been a busy year Richard had many topics to report on. The Council has campaigned on behalf of residents on local issues, there have been changes in personnel both with the Clerk and Councillors and, more recently, collaboration on joint issues with Wem Town

Council. Overall, the Council believes it now has the structure in place to assist and represent the Parish more effectively.

The meeting included short presentations from Shropshire Councillors Pauline Dee and Chris Mellings who outlined the work of the Local Joint Committee and a Shropshire Councillor. The Parish Council were pleased that Community Police Officers Lesley Mitchell and Antony Jones also attended. Their presentation centred on the work carried out in the community and gave examples of how positive assistance can change not just communities but the lives of individuals.

The meeting was attended by more the 30 residents and concluded with an informal question and answer session. The general feeling was that it had been a worthwhile meeting with interesting and informative speakers on matters relevant to all.

## **BUDGET 2011/2012**

At its meeting on Tuesday 4 January the Parish Council agreed its Budget for the year 2011/12. Although the day to day functions of the Parish Council continue to grow, the Parish Council agreed to ensure communication with residents and assistance with the Parish Plan were provided for. The Precept was set at £12,193 which involved no increase to local tax payers.

Chairman Richard Powell said that Wem Rural Parish Council appreciated the present economic difficulties and had worked hard to achieve this zero percentage rise without cutting back on areas which would help the community.

# GET INVOLVED WITH 'RURAL WATCH'

Rural communities are proving how effective it is to "get involved" by signing up to help tackle crime in their villages and hamlets. Rural Watch, information sharing and advice scheme, which was set up in Shropshire last year now has more than 570 members and continues to go from strength to strength.

Although we live in a relatively low crime know area, we all someone who has been victim of crime such as theft. Rural Watch is a two way information sharing scheme where Police inform members any potential threats quickly and easily.

Just as importantly, members are able to information share about such matters as suspicious persons or vehicles with the Police and other members. Messages are sent via email. voice or text within hours of an incident place which taking means warnings and appeals for information can quickly be issued to relevant people.
