# SG22/13 Public Participation Time

#### SG24/13 Minutes of the meeting held on 4 April 2013 to be approved and signed.

The Minutes of the meeting were approved and signed following one amendment to SG19/13 date changed from 2007 to 2009.

# SG25/13 To review feedback from the Drop-in Event at Wem Cricket Club on 9 April 2013.

General discussion took place and the following key points were made:

- The Clerk advised that to date the 37 survey forms had been returned. The scale scores were as follows:
  - 3 forms rated 9
  - 1 form rated 8
  - 1 form rated 5
  - 3 forms rated 1
  - 26 forms rated 0
  - 3 forms rated 0 with attached letters.

The Clerk advised that following a review of the comments no new issues appeared to have been raised. The deadline for responses was 19 April.

- Mr van der Westhuizen questioned the forms rating 8 and 9 as his perception was that no supporters of the scheme had attended the event.
- Mrs Pugh considered that any proposed tenants could have found the event intimidating and may not have made their views known.
- The Clerk reminded members that the purpose of the survey was to judge people's
  opinion after they had attended the event and heard first hand about the project.
  It was clear that some attendees were taking multiple forms away and then
  returning them completed by people not attending the event. The results of the
  survey against its original purpose were therefore questionable.
- It was clarified that the purpose of the event was to inform and not prove housing demand.
- Comments made from attendees were noted.

Cllr Murgatroyd wished to record that the comments made by Mr S Forrester were totally inappropriate. Cllr Staines stated he was disappointed with these views and he was sure they were not representing the views of the majority of residents in Church Lane, Ash Grove and Soulton Road.

• Mrs Howell agreed to provide a breakdown of the Wem Rural waiting list and the 90 re-lets in Wem Rural and Wem Urban since 2009.

- Further clarification was required regarding traffic along the Soulton Road/Level Crossing.
- Site visit with Highways Officers
- Causes of flooding behind Ash Grove.
- Confirmation of the capacity of the attenuation tank and that it can cope with a level of rain water similar to last 12 months/winter.
- Action is Shropshire Council taking regarding the over capacity of St Peter's School
- Copy of a Tenancy Agreement
- Empty Homes review of the Parish
