Opening and Ribbon Cutting Ceremony

During the event Wem Cricket Club was presented with a special commemorative bench as a thank you for their support and help during the construction of the new homes. They provided car parking when necessary and a venue for local residents to meet.

On Monday mornings at 10am a small group of people meet at Edinburgh House, Wem, and go for a walk. They walk for about an hour before going to a local café for a drink afterwards. These people do not see themselves as walkers, but as someone who wants to get out of the house for an hour or two, meet up with other people and have a chat. These walks are for those who know they need to get out and do a bit more exercise but have not yet done anything about it. coming on a Monday they are taking the first step to being more active without having to wear specialist clothing, and getting the

chance to talk to other people. The walks are mostly on the flat and led at a pace that suits

So if this sounds like something you might enjoy why don't you come and join them? No need to book, just come along 5-10 minutes before the start of your first walk. Wear comfortable flat shoes with a good grip.

FUTUREdevelopment

Included with the June edition of the Rural Review was the consultation document asking for views on future development in the Parish. Only 15 responses were received but these covered a wide range of views.

The Parish Council is committed to holding a Parish Meeting where the issues consulted on will be discussed but it will be combined with the issues surrounding the delivery of Broadband (article on page 4), a topic that has received substantially more feedback from residents.

AN UPDATE ON DEVELOPMENT ACROSS THE COUNTY

At the time of going to print, Shropshire Council has received the final report from the Planning Inspector on the Site Allocation and Management of Development Supplementary Planning Document (SAMDev). It is planned that the Policy will be adopted by Shropshire

Council at its December meeting. Once adopted and with Shropshire confirming it has a 5 year land supply, Shropshire Council hopes the number of speculative applications for new housing received over the last couple of years will subside.

Wem Rural Parish is classed as 'Countryside' under Planning Policies which means no new open market housing should take place. However, the Parish has seen applications for open market development submitted to Shropshire Council. These have been assessed by the Parish Council through the formal consultation process on their merits against Planning Policies and local benefits. To date, Shropshire Council has refused applications. although one has subsequently been approved through the appeal process.

COUNCILLOR

With the recent resignation of Bev Horsley there is a vacancy for a Parish Councillor for the Edstaston Ward of the parish. As this vacancy has arisen between the ordinary round of elections (normally every 4 years) it is classed as a Casual Vacancy.

Notices will be placed on notice boards around the Parish and on the Wem Rural website advertising the vacancy from 1 December 2015 for 14 days (excluding weekends and bank holidays).

During this period of 14 days, ten electors from within Edstaston Ward can call for an election to be held. To do this they need to make their request in writing to Shropshire Council.

If an election is not requested the Parish Council will be notified to co-opt a member to fill the vacancy.

BROADBAND in the parish



In the previous Rural Review in June we asked for your comments on the broadband service that is available in the Parish. To date we have had over 60 responses. Unsurprisingly all responses so far have highlighted the poor band width available in the parish and the subsequent impact this is having on parishioners' lives.

As a result of the responses the Parish Council has investigated a number of alternative options to support a significant improvement in the bandwidth available across the parish. We have concluded that a Wi-Fi solution is not viable for the parish. However we are currently running a trial of the delivery of broadband via satellite. The trial started early November 2015 and we hope to have some meaningful results early February 2016.

In the meantime we are still keen to get more feedback on the current broadband service and so if you have not yet had time to register your comments please take the time to do so at www.wemrural-pc.gov.uk/broadband-speed/. It would be very useful to establish the current broadband speeds across the parish so if you are able to provide this information at the same time it would be very useful.

ROADWORKS: A Review

We all have been affected by recent road works, both in Wem Rural and neighbouring parishes, and work continues on the B5063 north of our parish. Although many people's journeys to work, school or shopping have been more difficult due to the required diversions (and unofficial ones), the results have been worthwhile as the standard of road surfaces appear to be of good quality.

One project however, did cause concern to the Parish Council. The works carried out at Ryebank and Highfields included the removal of the grassed island and a change of road layout at the Highfields junction. The Parish Council was not aware of these changes until they had been completed. At the request of the Parish Council, Traffic Engineers from Shropshire Council have reviewed the layout and consider it to be an improvement. The Council has subsequently requested additional signage to bring the new layout to the attention of regular users.

At Palms Hill vehicles continue to speed. The retaining walls have been struck by vehicles with debris now falling into the road. The Parish Council has lobbied Shropshire Council to review the safety of the retaining walls and work is scheduled for 2017/18.

GRANTS

Annual grant scheme and Community-led Grant

Wem Rural Parish Council awards grants on an annual basis to voluntary organisations and community groups. The paramount concern of the Council is that any grant application is beneficial to residents of the parish. This year's deadline is 23 January 2016

All applications will be considered on their individual merits. The final decision on assessment of applications and the level of any grant offered lies with Wem Rural Parish Council.

Local voluntary organisations, community groups and sports/recreational clubs can apply. All must be non-commercial, have a constitution, set of rules or documented aims and objectives and have a bank account with at least two signatures. Individuals may apply for grants if submitted by an organisation to which they belong. The organisation is responsible for

ensuring the grant is used for the purpose for which it was granted.


Grants can be used for capital projects or for revenue purposes but only for the purpose specified in the application.

Community-Led Grant

Following the completion of Round Meadow the Parish Council was granted £69,000 by Shropshire Council under its Community-Led Housing Scheme.

The criteria set by Shropshire Council for its use is the same as for the Neighbourhood Fund element of the Community Infrastructure Levy. It cannot be used for the day to day expenditure of the Parish Council. The Parish Council is considering the best use of this Grant and will report in future issues.

Automated External Defibrillators (AEDs) are installed at Robinson and Young, Edinburgh House and the Co-op due to the generosity of local people, community groups, publically funded organisations and the Co-op.

They are maintained and used by groups of volunteers from Wem Town and Wem Rural, supported by West Midlands Ambulance Service. If there is a cardiac arrest the Ambulance Service, as well as sending an

ambulance, will make a call to the teams of volunteers, and the first available person will collect the AED and attend.

Both Town and Rural Groups need more volunteers. Would YOU be willing to make sure the AED is available to everyone in our community?

West Midlands Ambulance Service will train volunteers in AED use for free.

"WEM INTO WORK" SCHEME **SEES RESULTS**

Wem Town Hall is demonstrating how with focus. determination and some support funding its residents' lives can be changed for the better.

'Wem into Work' has helped 37 people move from unemployment to finding work in the past 18 months. This represents a success rate of over 50 per cent of the clients the scheme has sought to help.

The scheme has been possible thanks to investment and support from the Police and Crime Commissioner. Shropshire Housing, Wem Town Hall and DCLG Transformation Challenge Award through Shropshire Council.

Project Leader Sarah Zacharek, who is employed by Wem Town Hall Community Trust, said that in a recent review the project had been 'a huge benefit to the town'.

On behalf of the Police Crime Commissioner, Community Ambassador Graham Oliver said: "It is a known fact that an aid to reducing crime is to have people in employment; it also helps reduce anti-social behaviour."

Sarah, together with a volunteer, a semi-retired teacher, use their varying backgrounds in business, literacy, interview techniques and CV development to give those who are referred to them a better chance of gaining employment.

Building self confidence is also a key element as is guidance with job searches, even a change in job options. Wem Town Hall works with Job Centre Plus and the local community offering the bespoke support to local unemployed people to help them secure employment and local businesses to fill vacancies

Based at the Town Hall every Tuesday, support is provided to individuals who have been unemployed for less than 52 weeks. Help with job searches, updating CV, interview skills, confidence building, general computer skills and securing work placements is offered. Computers are available throughout the day to enable clients to carry out job searches independently.

RURAL POLICING

Earlier this year at our Annual Parish Meeting we had a presentation from Sgt Claire Greenaway (West Mercia Police) and Roger Ashton from Farm Watch. The emphasis was on rural crime and its prevention.

Although we don't like to think that we might be victims of crime, there are things we can do to prevent or discourage it. If you have access to the internet there is plenty of advice on the West Mercia Police website and other Police Authorities.

An easy way to assess your own risk is to take time to walk round your own property and imagine you wanted to break in to steal; work out how you would do so and what you would do to prevent it. Then look at items of value and decide how you would identify them if the worst happened. Yes, this seems all very simple, but how many of us can honestly say we have done this?

You can also make use of a facility called Immobilise, where you can securely register your possessions and more easily identify them if lost or stolen. It has the support of Police Forces across the country, including West Mercia, and also has useful information on how you can make your belongings more secure.

What happens if you need help? Our local Whitchurch Safer Neighbourhood Team, also

covers Wem Town and Wem Rural and should be your first point of contact. More details are on the West Mercia Police website, and the Safer Neighbourhood team can be contacted by calling 101, or by email whitchurch.snt@westmercia.pnn.police.uk. The team are prepared to visit homes and premises to give advice on crime prevention, probably the only time you would be happy to see a police car on your drive!

Closely associated with the Police are the Watch Associations. Roger Ashton is the Neighbourhood and Farm Watch Coordinator for Aston and Lee Brockhurst. 
