HIGHWAYS UPDATE



Community Concerns

Registering a 'Community Concern' under Shropshire Council's Road Safety Policy is one way the Parish Council can bring to the attention of Shropshire Council's Highways Team and the Police issues with our local roads. Councils can register up to 15 concerns each year for consideration.

If successful the concern can be addressed in various ways; this could include highway design and speed management, highway maintenance or driver behaviour through training and publicity.

So far this year the Parish Council has put forward speeding issues along Aston Road (a joint concern with Wem Town Council) and the extension of the 30mph speed limit to the eastern side of the entrance of the Wem Industrial Park. We hope they will be given favourable consideration.

Last year's concerns included: Pepper Street Quina Brook, Ossage Lane, Lowe Hill, Newtown and Palms Hill. We await their results.

If you have any new concerns please let your Councillor know.

B5063 Barkers Green / Tilley Green Junction

Users of this junction will know how difficult it is to negotiate especially during the summer months when visibility is hampered by the hedges.

However, good news!! The Parish Council has been talking to the owner of the land on the Palms Hill side of Tilley Green and he has agreed to remove some hedgerow to improve visibility. Before any work could commence the Parish Council had to apply permission to remove the hedge. Permission was granted this month.

We will have to wait until later in the year to remove the hedge to allow any nesting birds to vacate.

The Parish Council thanks the landowner for his generosity and support with this matter.

ROUND MEADOW RESIDENTS REVIEW

Spotlight On: Shropshire Councillor Pauline Dee

Every 4 years, all County, Town and Parish Councillors must step down from their roles and all residents have the opportunity to consider standing as a Councillor. This 4 yearly event is called a 'normal election' and will take place next May. In preparation for this process, Rural Review begins a series of articles on what is involved in being a Councillor and the role of Councils. We start with asking Shropshire Cllr Pauline Dee about her role within Wem Rural Parish.

"I have been a Governor of Newtown CE Primary School for several years and have been co-opted as a Governor to the Newhampton C of E Schools Federation. This has enabled me to get to know parents and children when I attend events at the school. For many years I have held weekly surgeries on Thursday mornings (except when Council meetings are held) so I can meet residents from across the Wem Division. I have always made myself available for people to visit or phone me at

I attend as many Wem Rural Parish Council meetings as possible to keep up to date with their work for the residents they represent. It can be very rewarding working together to see how, by cooperating, we can make improvements in our environment and communities, particularly with the shortfall in funding for local services."



NORTH SALOP WHEELERS

Many Parish residents will be aware of and use the Community Transport Group, North Salop Wheelers. Based in Whixall, they provide a service for residents who do not have access to other means of transport i.e. car, train or bus service. They operate 4 days a week covering Wem, Whitchurch, Ellesmere, Market Drayton and the villages and hamlets in between.

What you may not be aware of is that their London Cab and Minibus are available for hire by community groups on a driver or self-drive basis. The Wheelers need £5,000 funding each year to maintain their invaluable service and this may be a practical way of solving your need and donating to this 'not for profit' organisation.

The Wheelers are currently looking to expand by taking on the service from Market Drayton to Telford which is being cut by Telford and Wrekin Council. This would assist people needing to visit the Princess Royal Hospital of the Magistrates Court. Telford is now the only Magistrates' Court following the closure of Shrewsbury Magistrates' Court.

What is a Federation?

Under the Education Act of 2002, schools and local authorities can propose that between two and five schools join together to create a federation. A federation is a group of two or more schools with a single governing body. It is a way of bringing schools closer together. The schools then combine their governing bodies into just one governing body for the federation. This allows the federating schools to pool resources and leadership and teaching expertise.

Included in strategic vision of the Federation for 2017

The newly formed single Governing Body of Newtown C of E Primary School and Welshampton C of E Primary School includes members who bring a set of skills and expertise that enables each of the schools to fulfil part of their strategic vision of our schools — ensuring that each pupil is given the opportunity to reach their full potential within an environment of excellent education and care; according to their very own aspirations, unique needs and abilities.



Have your say on plans for a new electricity line for North Shropshire

- New overhead line needed to support and enable growth in North Shropshire
- Communities have important role in developing the line route
- Stage One Consultation open from 29th June to 9th September 2016

SP Energy Networks is planning to invest £18m in order to support and enable growth across North Shropshire. This investment is to reinforce the electricity distribution network by constructing an overhead 132,000 volt wooden pole line from Oswestry substation, located at the A5/A495 roundabout, to Wem substation, located on Ellesmere Road, Wem.

This line will provide capacity to support development on land allocated for new jobs and homes in Oswestry, Whitchurch and Wem in current planning forecasts to 2026.

Route for the new line

SP Energy Networks need to find a suitable route for the new electricity distribution line. Feedback from the local community will play an important role in assisting them to establish the final line route.

They have carried out a considerable about of investigatory work to look at and consider the location of communities, heritage features and other sensitive areas. From these investigations SP Energy Networks have developed a number of proposed routes that seek to either avoid or mitigate impacts on these areas. Section 4 of the route from Loppington to Wem includes an option for the final route.

SP Energy Networks have opened a consultation to enable people living in the area to have their say about the proposals. This is stage one of a two stage consultation. They will use the feedback together with their assessments to establish the most appropriate route in order to reinforce the North Shropshire electricity distribution network. Your views really can influence our work, so you are encouraged to take part in this consultation process.

SHROPSHIRE COUNCIL'S TRANSFER OF ASSETS AND SERVICES

You may have read in the local press that, as part of reducing costs, Shropshire Council are actively encouraging Town and Parish Councils to take on assets and services. There are no assets within Wem Rural (eg buildings, green spaces etc) but, it is expected in due course, the Parish Council will be asked to consider taking on some environmental tasks (eg verge cutting).

As with any transfer of this kind there would be on-going costs which would lead to an increase of the Precept, the amount paid by council tax payers, to the Parish Council. The Council would explore ways to keep these costs to a minimum, for example, working with neighbouring councils. However, prior to any decision being taken the Council would seek the views of Parishioners.

We will keep you updated through this newsletter.

Are You A Carer?

Caring for someone else's needs can be both very stressful and isolating. There are services available to help you and other carers across Shropshire look after their own needs as well as the needs of those you care for.

You may already be a registered carer, but even if not, you might need support in the future, or have a friend or relative for whom this might be an issue, so this could be important.

Carers registered with Shropshire Rural Community Council (RCC), will already know that earlier this year there was a change in the way some services are provided. In particular the Carers Support Service has transferred to Carers Trust 4 All.

It's easy to think that with government cuts in funding of many types of provision, and the the increasing care needs in our communities, support for carers could be at risk. However, there are a number of services RCC continues to provide. Just as an example, there is the iCare Card Scheme, where if you are an unpaid carer you can apply for a discount card for over 40 businesses in Shropshire. The RCC also provides information and advice to people who care for family members, friends and neighbours through a Support Line on 01743 341995 from Monday to Friday 9am to 4pm. Enquiries range from social services, equipment, finance, care homes, holidays and leisure, care at home and many more. You can be referred for benefits checks and signpost to specialist organisations where necessary. Note also that Shropshire RCC doesn't only support carers. There are other services provided for the wider community that you may find useful. If you want to find out more, see below.

In addition, as part of Shropshire Council's 'Get Involved' initiative, its Health and Wellbeing Board has launched a consultation involving a Draft Strategy for supporting carers, proposing six Priorities for carers. Alongside that is a survey seeking views on the strategy. All Parish Councils in Shropshire have been asked to publicise this project, and particularly in rural parishes, where carers might feel more need for support, it is hoped that as many parishioners as possible will come forward to complete the questionnaire.


