# Minutes of the Meeting of the Parish Council held on Tuesday 5 February 2019, in the Roden Suite, Edinburgh House, Wem starting at 7pm

#### 14/19 Public Participation Period:

A member of the public spoke in support of a development site within Wem Rural Parish. He and partners proposed that the site be included in the Local Plan Review as a preferred sites for Wem Town. They had spoken to Wem Town Council at a recent Town Council Committee meeting. The member of the public explained the benefits the site had over the other suggested site for future development around Wem.

Councillors had the opportunity to ask questions of the member of the public. The Clerk explained the Parish Council had responded to the latest consultation on the Local Plan Review and that several hamlets had been put forward as a development Cluster. Individual sites were not required to be identified.

#### 15/19 Proposed Tilley Conservation Area:

Dr George Nash explained the context and background to the proposal. The proposal had followed on from the Tilley Timber Project. He advised 13 questionnaires had been issued and 9 returned and that there was support for Tilley to be classed as a Conservation Area from residents.

Shropshire Council officers advised that the Council's consultation was the formal consultation and a decision would be made based on Council policies.

Councillors asked questions of Dr Nash and Shropshire Council Officers to understand the process of consultation and the impact of the designation.
