### **SmartWater Kits Now Available!**

Saturday 21 September was the launch of the Police, SmartWater and Parish Council's initiative "We Don't Buy Crime". Residents from all over the Parish came to Edstaston Village Hall to collect and register their free SmartWater kit.

To remind you...

SmartWater is a sophisticated security system that protects property, deters thieves and helps the police to convict criminals. It can be directly applied to valuables or it can be used to spray criminals committing a crime.

SmartWater contains a unique forensic code that is registered to an address or location. Anything marked can be traced back to where it came from, allowing the police to identify stolen property and link criminals to crime scenes.

SmartWater is almost invisible in natural light but glows brightly under ultraviolet (UV) light.

Contact your Parish Councillor and collect your FREE SmartWater kit. If sufficient kits are distributed, the Police will contribute to their cost.

# Last Ditch Attempt To Save Wem Moss!

Regular readers of this Parish Newsletter may recall that we are fortunate enough to have in our Parish one of the country's rarest wildlife habitats, Wem Moss, which is part of The Fenn's, Whixall, Bettisfield, Wem & Cadney Moss Complex (The Marches Mosses). Wem Rural Parish Councillors were invited to see how the BogLIFE project was being managed locally.

Wem Moss is managed by Natural England and Shropshire Wildlife Trust and is separated from the rest of the complex by farmland. Together, the Marches Mosses form Britain's third largest lowland raised bog, is a Ramsar site of international nature importance for several plant and animal species and is large enough to be visible from space. As well as importance as a wildlife habitat, maintaining peat bogs offers a primary approach to climate change mitigation as they can lock up vast quantities of carbon. So not just one, but two important reasons for saving the Mosses.

The Wem Moss is a Raised Bog, meaning it is domeshaped, and it consists of peat made up of Sphagnum moss and other moisture-loving plants that has built up continually since the last Ice Age 12,000 years ago.

However, along with the other areas of the Marches Mosses, it is subject to a number of environmental threats. The key threat is the gradual drying out of the bog and the consequent loss of habitat; this can be seen by the rise of heath plants such as purple moor grass, birch and ling heather, and the decline of Sphagnum moss, which both requires and preserves the wetter conditions as its spongy form holds water. Another bog plant previously present in large numbers, the Sundew, seems to be almost absent from Wem Moss.

In the recent past, piles have been sunk into the peat to stop water percolating away, but now a new technique is being implemented. Bunding consists of creating a series of interlocking low ridges, formed from the peat itself. Although only 10 or 15 cm high, these ridges – the bunds – form a cellular network of relatively impervious barriers that retain water to form lagoons in which the moss can regenerate thus restoring the rehydration and raising of the bog.

But water reduction is not the only reason for changes in the Mosses. Bog plants survive best in acidic, low nutrient conditions but we are experiencing rising ammonia levels in the local atmosphere and that is both neutralising and adding nutrients to the moss as it rains, further impeding the growth of Sphagnum and other bog plants. However, the signs are looking good for our wilderness area; in the areas where bunding was carried out last year there are already signs of returning wildlife typical of wetter moss, including Sphagnum moss itself and species such as dragonflies, Curlew and Lapwing.
