Planning Applications Received - to consider response

20/03483/FUL Long Barn, Northwood, Wem, SY4 5NP The siting of five converted container units to provide holiday accommodation together with associated drainage facilities and increased parking provision. A review took place on the application as submitted and the consents issued from previous applications. There appeared to be issues relating to specific conditions within those consents. Councillors expressed serious concerns as to whether all current activities and development were authorised. There were also concerns with the current proposed development.

It was resolved to object to the application until existing issues were addressed.

Highways: It was appreciated that the entrance was already in use, but the proposed development would result in additional traffic over a short period most days. It was asked whether the entrance should have improved visibility. Noise: It was noted that the development is in a rural location, but 20 dogs can make a significant amount of noise. It was asked whether insulation of the kennels had been considered or recommended.

Flooding: The response by WSP on behalf of Shropshire Council was noted and the Council would ask to be re-consulted, once the applicant's preferred option has been submitted for review.
