- i. 20/03950/FUL Brook House, Newtown, SY4 5NU  
Erection of two storey rear extension following removal of conservatory  
Decision: Grant Permission
- ii. 20/02724/FUL Rye Bank Farm, Rye Bank, Wem, SY4 5RA  
Erection of general purpose agricultural building for the storage of agricultural equipment and hay  
Decision: Withdrawn

**b. Planning Applications Received - to consider response**

- i. 20/03483/FUL Long Barn, Northwood, Wem, SY4 5NP (review)  
The siting of five converted container units to provide holiday accommodation together with associated drainage facilities and increased parking provision  
**The Council noted that the application had received consent since the agenda had been issued. The Council was extremely concerned that its comments had not been taken into account including the request for the application to be heard by Shropshire Council's Planning Committee. The Council requested the Clerk to take forward its concerns with Shropshire Council Planning Officers.**
- ii. 20/03690/FUL Greenfields, Ossage Lane, Whixall, SY13 2QB (review)  
Erection of Animal Rescue Centre to provide a 20 unit kennel building and a 8 unit cattery; to include all associated works  
**The Clerk advised further information was expected and therefore it was agreed not to review the application at this stage.**
- iii. 20/03017/FUL The Little Wickett, Rye Bank, Wem, SY4 5RA (review)  
Erection of a local needs dwelling including garage and access  
**The Ecological Appraisal and assessment by apt Group was noted. However, the Council could not agree with the planning officer's comments of 3 September that the gross internal floor areas was 100sqm. This was based on a review of the scale on the plans.**
- iv. 20/04738/FUL Units E11, Wem Industrial Estate, Soulton Road, Wem, SY4 5SD  
Extension to existing industrial unit  
**It was resolved to support the application.**

- v. 20/05127/VAR Newtown C Of E School, Newtown, Wem, SY4 5NU  
Variation of Condition No.2 attached to planning permission 10/04754/VAR dated 21/12/2010 to allow for the retention of the demountable units for a further temporary period of ten years  
**It was resolved to support the application to ensure the education of the pupils at the school. However, the Parish Council was very disappointed that no permanent solution to provide 150m2 of floorspace had been found during the 20 years since the original approval. The use of demountable accommodation was unsustainable and a false economy. The Parish Council requested the Property Strategy and Review Team advise the future intentions of replacing the temporary accommodation.**

- vi. 20/05137/FUL 74 Coton, Whitchurch, SY13 3LX  
Erection of first floor extension and balcony  
**It was resolved to support the application**

***Cllr Nicholls left the meeting***

- vii. 20/05273/HHE Grange Farmhouse, Pool Head, Wem, SY4 5QY  
Erection of a single storey rear extension to a detached dwelling, dimensions 4.70 metres beyond there rear wall, 3.40 metres maximum height and 2.25 metres high to eaves

It was resolved to support the application

**c. Consultation: Local Plan Review - Regulation 19: Pre-Submission Draft of the Shropshire Local Plan**

The consultation was noted. Comments regarding the difficulty of reviewing such an extensive document were made, which Cllr Mellings agreed to forward to the Planning Policy team.

**06/21 Parish Clerk's Report:**

**a. Gigabit Broadband Voucher Scheme: Shropshire Council Top-Up Scheme**

The Clerk advised approximately 135 responses had been received. She encouraged Councillors to contact residents to respond. General discussion took place on the poor quality of Airband's wireless broadband provision in the Parish. Cllr Mellings agreed that he would arrange a meeting with Connecting Shropshire to discuss the issues.

**b. National Census 2021**

The Clerk advised the Census would still take place in March.

**c. Shropshire Council Housing Needs Survey 2021**

The Clerk advised it was expected that a Survey would be carried out in the Parish this year.

**d. Annual Parish Meeting – March 2021**

The Clerk advised that at the time the agenda had been issued, she had hoped a Parish Meeting would be allowed. With new COVID-19 restrictions in place, this did not appear possible.

The Clerk advised that should elections take place this year, the May meeting may need to be delayed.

The Hospice's ability to fund raise had been severely restricted due to COVID-19 and their costs (eg additional PPE) had increased.
