The Parish Council was extremely disappointed to note that after withdrawal of the application, work continued on site and now appeared to be nearly complete. This current application was validated on 13 September 2021. To continue work was a flagrant disregard of the planning system.

It was strongly recommended that a planting scheme for the stopping up of the redundant existing access is made conditional.
