#### 146/21 Public Participation Period:

A resident from Barkers Green spoke about the road closure at the railway bridge and the volume and speed vehicles were travelling at through Barkers Green having ignored the 'no through road' signs. He had tried contacting Network Rail and Shropshire Council but no action had been taken. Barkers Green had become a rat run and an accident was waiting to happen.

The Chair sympathised with the residents and advised other residents from Barkers Green had attended the November meeting. The Council was liaising with Shropshire Council to try to reduce speeds in all settlements in the parish.

The residents wished for traffic calming at the very least in Barkers Green.

All agreed volume of traffic had increased over the last 18 months as well as the lack of consideration to other road users.

Residents were advised how to contact Network Rail and would be supported by the Parish Council and Shropshire Councillors.
