## WELCOME....

to the latest issue of Rural Review. It's hard to believe that Autumn is upon us and I don't know where the time has gone. Being a local councilor is an extremely rewarding, interesting and exciting opportunity and over the last few months we have all been very busy working to improve and enhance the local community.

Wem Rural Parish Council is a Quality Gold standard council and that reflects in the projects we have been working on and those detailed in our action plan. We have allocated community grants to a number of local initiatives, including Newtown NCRA., and the parish council is also looking at investigating the need for new facilities locally to promote social interaction, sport and leisure.

Another really exciting initiative that the parish council has started has been in relation to improving further the Broadband and Mobile Phone infrastructure. We are part of a working group looking to bring superfast fibre broadband to more areas in our rural community. We are doing this by working with Connecting Shropshire, Openreach and Airband exploring the feasibility of a Gigabit Community Project. After a very slow start, Openreach has identified potential areas and are now in the process of assessing the cost of installation, ready for the parish council to review.

We have also been working very closely with the Highways department at Shropshire Council and our clerk is part of a very active working group to address the concerns residents have expressed about the state of the roads across the Shropshire Council area. It is possible the parish will be chosen to trial some new approaches to highway maintenance. Road safety has also been an issue raised by local residents and as a parish council we have undertaken surveys of the type and volume of traffic in the Quina Brook area and are about to do something similar along Ossage Lane.

Concerns expressed about rural crime are being actively pursued by the parish council and we are working in conjunction with the police and other services to promote the various "Alert" & "Watch" services and the Police and Communities Together (PACT) initiative. Our local police are invited to monthly council meetings and we are due to meet with West Mercia's Police and Crime Commissioner and the area inspector to discuss local issues.

We are also extremely proud to be part of the Wem Economic Forum and the Wem Area Climate Forum, working with local residents and businesses to reduce the local impact of climate change.

We have some councilor vacancies at the present and I hope the brief projects outlined above show the very real difference being a local councilor can make. Having achieved Quality Gold standard reflects the hard work and dedication our clerk and the rest of the councilors have made over many months whilst contending with local, county, country and global challenges. If you think you may be interested in such a role and make a difference then please contact our parish clerk or myself.

## Community Transport Post-Covid: North Salop Wheelers



Following the enforced stoppage of community transport services under Covid restrictions, both Phoebe Ashton and John Harrison - the guiding lights of North Salop Wheelers which they co-founded some eighteen years ago - have decided it is a good moment for them to retire. Community transport in the North Shropshire area is thus in urgent need of new energies. In September, Shropshire Councillor, Edward Towers, convened in Wem a meeting of interested parties which in turn instigated a Covid-delayed NSW AGM in early October. A new organising committee was formed: Cllr Andrew Everett and Dr Robin Nelson were voted in as new Chair and Secretary respectively, and Phoebe Ashton and Caroline Turver agreed to continue serving for an interim period, as Treasurer and Facebook co-ordinator respectively. Four of the passenger representatives were also confirmed as Committee members: Mavis Hards (Ightfield); Audrey Hardwick (Prees); Andy Jones (Whitchurch) Janet Nowill (Coton). A strong feeling was expressed at both meetings that there is now - and will be in future - a need for community transport in the North Shropshire area.

The committee is mandated in the first instance to revive and sustain the current provision of North Salop Wheelers, in particular the regular market services to Market Drayton (Wed); Wem (Thurs) and Whitchurch (Friday). It aims also to sustain its contribution to Shropshire's Voluntary Car Service which provides transport for people with special requirements. Working with Shropshire Council Community Transport Services and the Shropshire Community Transport Consortium amongst other partners, the Committee is also mandated modestly to build the service in line with the government's "Bus Back Better" national bus strategy. For example, Cheswardine Parish Council has expressed a wish to be included. The idea is that volunteer-run community transport services might co-ordinate with an improved, commercially-run, national bus service to make for better provision overall. Shropshire Council recently conducted an online survey about the strategy which received an unusually large response - indicating the level of local concern. The national strategy includes "a rural mobility fund" to which Shropshire Council might bid. So, there is much to be done by many people and organisations in the forthcoming months.

North Salop Wheelers is run largely on a volunteer basis, drawing upon professional services only where necessary to comply with the law and with DVSA (Driver and Vehicle Standards Agency) regulations and protocols. Particularly at this moment of transition, it would welcome additional volunteers to come forward. Drivers require no formal training though they must be medically fit to drive in accordance with DVLA requirements. Besides drivers, NSW would welcome volunteer assistance with administration (e.g. accountancy/ insurance, publicity), or with advice on logistics, vehicles and their maintenance. If you are interested in registering as a volunteer or expressing a view, please contact Cllr Andy Everett at Wem Town Council in the first instance.

Check **NOW** before the land gets too wet. Are your ditches clear? Were the roads near you flooded last year? Can you improve the situation before this winter?

#### Helping all our Road Users

# Cyclists killed on British roads increased 40% in 2020 (Department for Transport) What can cyclists do to help?

Cycling has become increasingly popular on the Wem Rural roads in the past two years.

Cyclists (and walkers and horse riders) can wear high visibility clothing. Cyclists can help even further by using flashing lights. Keep ears open for traffic noise.

Black or dark clothing is less easily spotted in the long shadows of tall hedges.

### What can drivers do to help?

Drivers on our rural roads need to be vigilant and drive so they can stop suddenly. This means reduced speed! Narrow roads and concealed bends need full attention.

## What can landowners and farmers do?

It is hedge cutting time now (September to March). Are your hedges tall? Are your hedges obstructive? Do they overhang the road? Is there a verge so that a cyclist or a walker or a rider can escape from oncoming vehicles?









Progress on the Edstaston Village Hall extension project has felt frustratingly slow at times, mostly due to the effects of the pandemic. However, in July the gable window and bifold doors were finally installed and the boarding removed between the main hall and the extension - what a transformation! The light absolutely floods in!

In August the floor was levelled, September saw the plastering finished and the community was able to get painting. The new kitchen arrives this week and we're ready for flooring and the



long-awaited automatic entrance door should be installed within the next two weeks. Work on the patio and outdoor space is ongoing.

Edstaston Village Hall has continued to be used throughout the building work (following the government's Covid guidelines). Committee members and helpers have taken on the role of cleaning and tidying - we are so lucky to have such a dedicated community! A HUGE THANK YOU to everyone who has helped.



## More Kissing in Wem Rural!

You may recall that a while ago a kissing gate was installed at the end of Weir Lane, to the footpath that runs alongside the River Roden. We are pleased to report that the recently formed Parish Paths Partnership (P3) group for Wem Area, working with Shropshire Council's Outdoor Partnership Service, have installed not one, but two, more gates nearby!

The gates are located from a short distance down Weir Lane, providing easy access to the footpath across pastureland, leading to the sharp corner by properties in Barkers Green. As such the path provides a short cut which also avoids a stretch of the road which is difficult for pedestrians.

## VCH Shropshire





Of course none of us envisaged that a new disease would sweep the world in the following months. The disruption to our work is of no great consequence compared to the suffering that COVID has caused but the closure of libraries and archives forced us cease work. We are delighted to announce that the draft histories of eight of the Wem townships (Aston, Horton, Lowe and Ditches, Newtown, Northwood, Sleap, Tilley and Wolverley) together with an introduction are now available to read or download on our website. We say drafts because they lack illustrations and maps. And we welcome your comments and corrections. Edstaston and Coton, Lacon and Soulton remain to be done.

Given that all but one of these townships lacked a previous history, I hope you will agree that this represents a prodigious effort by Dr Judith Everard. Wendy Horton contributed the accounts of buildings.

Our focus has switched from Wem for the time being but we hope to return in the not too distant future to complete our work. We are slowly gathering material on Edstaston at the moment. And we will like to do Whixall as well to complete this corner of the county. As we receive no public funding, we need the support of our readers. If you have profited from reading the Wem history or the draft text, we hope that you will consider making a donation to advance our work.

For the moment, do enjoy the texts we have published; do let us have corrections and amendments. And if you haven't already bought the Wem history, copies are available in the Wem bookshop or direct from VCH Shropshire through our website.

## New Shropshire Local Mobile service brings support closer to rural communities

Following the successful launch of Shropshire Local Ludlow, Shropshire Local is now adding a mobile service to rural communities across the county. Shropshire Local Mobile utilises some of the existing mobile library bus routes and will stop at locations across rural Shropshire. The trial scheme plans to extend to more locations in the near future and follows the opening of the Shropshire Local Ludlow.

The mobile service will provide access to more remote and rural parts of the county without libraries or similar facilities, where residents may otherwise struggle to connect to council services. Shropshire Local Mobile aim to make the council more accessible to people, and make it easier for those in rural communities to find out more about local support services and how best to access them

Friendly and experienced team members will be on hand to provide a listening ear, advice and information to residents. Staff will talk to people about how people can access services from the council and other organisations, and can also offer advice on how to access these online.



## Northwood Community Speed Watch

After a break enforced by Covid-19, the Northwood Community Speed Watch team are back in action. They are looking for more volunteers — do you live in or near Northwood and could help?

#### How does Community Speed Watch work?

At agreed, safe locations, volunteers monitor the speed of passing vehicles with a hand-held speed detection device. Vehicles driving in excess of the speed limit are recorded on a log sheet and are passed to the Police. The aim is NOT to catch as many speeding drivers as possible but to encourage motorists to drive at a safe and appropriate speed.

## **WRPC Budget 2022/23**

The Parish Council will be discussing the Budget for financial year 2022/23 over the next couple of months with the budget and precept being agreed at the January meeting.

## **Defibrillators in Wem Rural**

The Parish Council has installed 4 defibrillators in the parish and we are often asked how they are looked after. The Council funded them with a grant from the National Lottery and works in partnership with Community Heartbeat Trust (CHT) with the on-going management. CHT is a charity whose aims are to help and support communities in the correct provision of defibrillators, but in sustainable, resilient and governance led manner. The defibrillators are located at Edstaston Village Hall, The Bull and Dog at Coton, Newtown telephone kiosk, and The Horse and Jockey at Northwood.

CHT ensured the Council obtained the correct defibrillator equipment for its location and task and conforms to the various legislative requirements, such as disability laws. They also review and ensure the storage cabinets meet the right requirements for the need, this means storage that will minimise condensation, is heated with the right type of heater, conforms to health and safety, as well as electrical safety requirements, and meets disability recommendations. Suitable cabinets are branded as meeting the 'ShockBox' standard.

CHT were the originators of the use of telephone kiosks for defibrillator use and now have around 1,000 sites using kiosks. They are the partner organisation to BT and the only approved installer from BT (despite what some organisations claim).

All defibrillators are registered onto the WebNos Governance system which ensures

the local ambulance service is aware of the location and status.







## Replacement of railway bridge Mill Street, Wem



Network Rail will be carrying out to replace the railway bridge above Mill Street in Wem later this year. This work will help to ensure reliable journeys for rail passengers and road users for many more years to come.

### When will the work take place?

We will be setting up our site compound in mid-November in the field alongside the railway behind Grange Park Hawk Plant Limited, with the bulk of the work being carried out on weekends and during the night time in December, and follow up work in early January 2022.

The core work will be carried out from 11pm on Friday 24 December to 4am on Wednesday 29 December when our staff will be working 24 hours a day, as no trains will be running.

#### Mill Street – Temporary road closure

For safety reasons, Network Rail will need to temporarily close the section of Mill Street underneath the rail bridge from Saturday 4 to Wednesday 29 December. Working with Shropshire Council, there will be a fully signposted diversionary route in place along the B5063/Shawbury Road, A49 and B5065/Soulton Road.

During the core work (from 11pm on Friday 24 December to 4am on Wednesday 29 December), in addition to the road closure underneath the bridge on Mill Street, there will be a single lane closure and traffic lights in place at the roundabout between the B4576 and the B5063 as well as a full road closure of the roundabout for 15 minutes on Sunday 26 December, whilst we lift the new bridge into place.

Network Rail will maintain pedestrian access underneath the bridge as much as possible while they are not working on it.

#### Changes to rail services

Buses will replace trains for passengers between Shrewsbury and Crewe on 27 and 28 December. Please see www.nationalrail.co.uk for more information.

## Shropshire Rural Communities Charity

Shropshire Rural Communities Charity (RCC) is committed to making life better for people.

Below are two services they offer to help with this winter's challenges

## **Bulk oil buying scheme**

The scheme started in September 2011 and is now the largest scheme in Shropshire.

With a support network of 30 local volunteer coordinators RCC make ordering oil hassle free and better value for money. Once a month they collate oil orders from right across Shropshire on a specified date. They then contact the oil companies to ask for their best price for a bulk order (typically 100,000 litres a month).

All you need to do is join, send RCC an order then sit back and wait for the price and supplier info. You will then pay the supplier direct following your oil delivery.

#### Free energy saving advice

Energy price hikes and a rise in the energy price cap mean that households are more at risk of not being able to heat their homes this winter.

As part of the Big Energy Saving Network, RCC's energy champion Nickie Long is offering free and impartial advice via a pre-booked telephone or Zoom call to anyone who is looking to save money on their energy bills or who is generally struggling to heat their home.

### RCC can help with:

- hints and tips on how to save energy in your home, and
- where you can access support you may be entitled

to, such as the Warm Home Discount scheme, Priority Services Register and The Green Homes Grant.
