# 114/22 To elect the Chair of the Council.

Cllr Edwards was unanimously elected as Chair.

Cllr Edwards signed the Declaration of Acceptance of Office.

### 116/22To elect the Vice Chair of the Council.

Cllr Slack was unanimously elected as Vice Chair.

#### 117/22 Public Participation Period:

A member of the public reported on his recent attendance at a Shropshire Council North Planning Committee meeting. He expressed his dissatisfaction with the location, room layout, lack of discussion on the application in question by Committee members and the resulting approval. The member of the public outlined the differences in the original application which had been refused by Shropshire Council and this second application which had been approved. He was concerned that this approval would lead to subsequent applications on small sites with too many horses.

A member of the public spoke in support of a planning application which was to be discussed at the meeting. The application was to develop a new house on a site which housed a commercial building. The building had been subject to burglaries and the application was to improve security. They outlined the progress the business had made and that it employed 3 local people. The member of the public stressed the development was to deter burglaries.

The Chair of Newtown Community and Recreation Association, supported by the Vice Chair and Treasurer, advised the car park project had progressed well over the summer. Feedback had been positive on the first day back at school. The Chair requested the Parish Council release the earmarked funds for the project of £15,000.
