Importance of Biodiversity to Wem Rural

You may have seen recently Sir David Attenborough's series 'Wild Isles', which revealed some very worrying facts about British wildlife. For example, one-quarter of our mammal species and one-third of our bird species are at risk of extinction Just one specific example of loss noticeable locally is that Lapwings are much less common than they used to be, perhaps you have noticed others. With only 13 percent of our land covered by woodlands we are the least forested in Europe, and half of that tree cover consists of non-native monoculture. This variety of life of animals and plants, and their habitats – **Biodiversity** - is not only important to our ecosystems, but also to humanity. It provides our food, makes oxygen, cleans our water and gives us medicines.

Threats to biodiversity, more particularly relevant locally, could be the intensification of farming, perfectly groomed fields, monoculture, habitat loss such as drainage of our wetlands, and growing pressures from urbanisation. 79% of Shropshire's land is managed for agriculture, which is 10% above the national average.

In addition, while we are very aware of the threat of global warming itself, scientists predict that loss of biodiversity could be a greater threat to humanity than climate change! The UK Government has supported the view that if we fail to halt and reverse biodiversity loss, by 2030 we increase the risk of further pandemics, rising global temperatures and loss of species. In order to prevent this, the Government is introducing the Climate and Ecology Bill. Following on from this, Shropshire Council (SC) is resolving to formally and actively support this bill. SC has set up a Shropshire Biodiversity Partnership, and Shropshire Wildlife Trust has several Nature Based Solutions for example focusing on woodlands, peatlands and wetlands. And as a Public Authority, the Parish Council also has a responsibility to conserve biodiversity, via the NERC Act 2006, and the Environmental Improvement Plan 2023, from DEFRA.

So what can Wem Rural Parish Council, and parishioners, do to meet this responsibility? WRPC has already supported the SC motion to support the Climate and Ecology Bill. When we receive planning applications we will check then for biodiversity implications, although Planning Officers already do this when relevant. We will be looking to develop and strengthen the Objective in our Action Plan which currently states "To lead the community on issues related to the environment and climate change".

How can biodiversity be increased in our parish? We should all think what contribution we could make, however small. Allowing any sized patch of land to grow wild is easy, and makes less work! Wildflowers grow better on nutrient-poor soil, so if early mowing is necessary, cuttings should be removed to avoid returning nutrients to the soil. If possible, reduce the severity of hedge cutting, and only mow a verge closest to the road, taking into account road safety. As far as larger areas of grass and hay is concerned, a well-known national agricultural wholesaler accepts that adding diversity to hay production can be tricky. Wild flowers and legumes can be added to improve diversity into hay mixtures, but if included, it may be more difficult to sell it on. However, if a farmer is using hay for his own livestock it would probably be easier to include a wider range of flowering species.

So wherever you are and whatever you are doing in Wem Rural, do something for our local wildlife, and please let the Parish Council know of any examples that move forward our Action Plan, and inspire others. Thank you on behalf of the Parish Council – and the Environment.

Climate and Ecology

The Motion to support the Climate and Ecology Bill was agreed by Parish Councillors at the Parish Council Meeting on Tuesday 4th April 2023.

The <u>Climate & Ecology Bill (2022)</u> formerly the CEE Bill is a plan for a new UK law that addresses the full extent of the climate and nature crisis in line with the most up-to-date science. The Bill is the only proposed legislation before the UK Parliament that ensures a comprehensive and joined-up approach to the emergency. The Bill, which was written by scientists, experts and campaigners, was first introduced in Parliament by Caroline Lucas MP in September 2020, and now has the backing of over 150 parliamentarians representing all major political parties and has the backing of Wem Rural Parish Council.

Mental Health of Young Farmers

According to a recent by the Farm Safety Foundation 94% of UK farmers under the age of 40 rank poor mental health as one of the biggest hidden problems facing farmers today. Further research published by UK Parliament goes on to say that the covid-19 pandemic may increase mental-ill health in farming with many not being able to seek help due to rural isolation and lack of awareness.

The Agriculture Industry in Shropshire report that Shropshire has the largest number of farm holdings out of all county and has the sixth largest amount of people working in agriculture out of all county and unitary authorities, behind Devon, North Yorkshire, Lincolnshire, Cornwall and Somerset making it an important issue for the local area.

Young farmers can access confidential support from Shropshire Rural Support, a small charity supported by a group of dedicated volunteers, all of whom live and are involved with rural Shropshire.

It has taken a huge amount of discussion and consultation to find the best way to move forward on what has turned out to be a much bigger job than previously thought!

If you've been to Edstaston Village Hall or just driven past you will have seen that work is progressing slowly on the car park with construction of a retaining wall and a safety fence by local builders KS Sheridan. The wall was backfilled using amazing girl power (Elaine, Liz, Anna and Sandra and Bev)

Next steps will be to use the existing sleepers around the edge to retain the surface planings, but before that drainage will need to be dug, levels sorted, stabilising and weed-proof membrane laid.... it sometimes seems endless!

Thankfully we have dedicated members of the community who with some funding from Wem Rural Parish Council will hopefully be getting together very soon (we're waiting for drier weather to coincide with free days at the hall) to finally get the car park into action!



Civility & Respect

Parish Councillors agreed that Wem Rural Parish Council would sign the Civility and Respect pledge.

By Signing the Civility and Respect pledge Wem Rural Parish Council agree to the following:

- ◆ All councillors, clerk and all employees, members of the public, representatives of partner organisations, and volunteers, will be treated with civility and respect in their role.
- Commit to training all councillors and staff.
- Sign up to Code of Conduct for councillors.
- Have good governance arrangements in place including staff contracts, and a dignity at work policy.
- Seek professional help in the early stages should civility and respect issues arise.
- Commit to calling out bullying and harassment when if and when it happens.
- ♦ Continue to learn from best practice in the sector and aspire to being a role model/ champion council e.g., via the Local Council Award Scheme
- ♦ Support the continued lobbying for the change in legislation to support the Civility and Respect Pledge, including sanctions for elected members where appropriate.

Wem Rural Parish Council agrees with The National Association of Local Councils (NALC), the Society of Local Council Clerks (SLCC), and One Voice Wales (OVW), that now is the time to put civility and respect at the top of the agenda and start a culture change for the local council sector.

Wheelie Bin Speeding Stickers

Wem Rural Parish Council have purchased a range of stickers that can be placed on Wheelie Bins in areas where speeding could potentially be an issue.

These stickers are a great visual reminder to motorists to drive safely, and stick to the speed limit along our busy roads. It is believed that temporary signs of this nature have a greater effect than more permanent signs.

You are required to show the correct speed limit for the road and please don't be tempted to leave your

bin out on the path/ roadside at times other than on official collection days.

You can email the Deputy Clerk to request a speed sticker and you will need to let them know what area they are needed for.



Telephone Poles

Openreach would like us to remind parishioners not to attach signs on their telephone poles as it can stop their engineers from working for safety reasons.

If you would like to put signs up on telephone poles then you will need to contact the National Notice Handling Centre who will check firstly if the request is feasible, they will then ask a local manager for their approval based on the locality (this can make a difference depending on the area, such as affixing a mirror to a pole may be fine in a rural area but more of a problem in a built up area etc).

The whole process can be quite lengthy as it sometimes requires a drive by visit etc. Once they have gone through this checking process they will either allow or reject the request. Their email address to send requests is NNHC@openreach.co.uk.

If an attachment is found that has not been approved then their engineers will remove it, if they can do so safely.

If they cannot remove it safely they would be expected to notify their manager, who will start the process of identifying the owner of the equipment to ask that they remove it. Of course this means that works that have been planned are delayed, faults can't be repaired, new orders for service can't be completed etc until the hazard is removed.

All of this comes at an expense and the owner of the attachment may be liable for these costs.

There may also be charged for any remedial works that are needed to make the pole safe again (right up to removing and replacing the pole if needed.


Problems with Potholes?

Potholes are caused by the expansion and contraction of ground water after the water has entered into the ground under the pavement and mostly occurs in Spring when temperatures fluctuate above and below freezing point more.

They appear in various sizes and shapes and can cause damage to cars if not repaired so it's important that we report them to Shropshire Council as soon as we see them – but do you know how?

You can report potholes on the Shropshire Council's website however there is an even easier way which you can do direct from your phone when you're out walking the dog!

Just download the Fix My Street App to your phone and when you see a pothole just take a picture, upload it on the App and mark the location. You will be notified when the pothole has been repaired and can track the progress of the repair and search for other reports in your neighbourhood.



Neighbourhood Matters

You can now sign up to Neighbourhood Matters to find out what's happening in the area and keep in touch with West Mercia Police through the free messaging service.

The Neighbourhood Matters messaging system enables residents, businesses and community groups to keep in touch with local policing teams. You can receive updates on crimes, latest information on ongoing incidents and learn more about what we're doing in your community.

You're invited to sign up and become a registered recipient of messages of information, crime alerts or witness appeals local to the area in which you live or work by email, text or telephone. Don't worry, you won't be bombarded with every incident as you can choose exactly the type of alert you wish to receive.

Be aware of Horses

The speed limit when passing horse riders or horse-drawn vehicles is 10 mph.

When passing a horse you should always pass wide and slowly.

You can find more information in Rule 125 of the Highway Code which states:

Be particularly careful of horse riders and horse-drawn vehicles especially when approaching, overtaking, passing or moving away. Always pass wide and slowly. When you see a horse on a road, you should slow down to a maximum of 10 mph. Be patient, do not sound your horn or rev your engine. When safe to do so, pass wide and slow, allowing at least 2 metres of space.

Horse riders are often children, so take extra care and remember riders may ride in double file when escorting a young or inexperienced horse or rider. Look out for horse riders' and horse drivers' signals and heed a request to slow down or stop. Take great care and treat all horses as a potential hazard; they can be unpredictable, despite the efforts of their rider/driver. Remember there are three brains at work when you pass a horse; the rider's, the driver's and the horse's. Do not forget horses are flight animals and can move incredibly quickly if startled.
