A little piece of Parish Council history

We have several beautifully bound ledgers that hold the minutes of council meetings between 1933 and 1992. They are going to be archived so we thought it might be interesting to share a snippet from the earliest meeting. The minutes are hand written as you can see from the image below so please excuse any minor transcription errors on my part. As you can see there are some topics that never go away.



Wem Rural Parish Council Minutes Corn Exchange Wem March 4th 1933

Present:

Resolved that minutes of the last meeting as read be confirmed and signed.

Resolved that the Clerk arrange to go with the Divisional Surveyor to inspect roads requiring repairs etc & report to the council at next meeting.

Proposed by Mr. Barkley and seconded by Mr. Weston that Mr.

William Davies be appointed a manager of Newtown C. of E. School in place of Mr. S. Harper resigned. *Carried unanimously.*

Proposed by Mr. Holland and seconded by Mr. Walker that Mr. Piercy Cartwright be re-appointed a manager of Edstaston C. of E. School. *Carried unanimously.*

Proposed by Mr. Cliff and seconded by Mr. Barkley that Messrs W Weston & Holland be reappointed Trustees of the Wem & Loppington United Charities.

Carried unanimously.

Resolved that the matter of obstructions of footpaths be left over until next meeting & that the Clerk bring before the Council the Ordnance Survey Maps of the districts concerned.

Signed. Charles Edward Forrester Chairman.

Plant Sale Couple Stand Down

For over 20 years Deborah and Clive have been the only producers of plants for the Annual Newtown Church and Afternoon Tea and Plant Sale.

Whilst it has been a terrific fundraiser for the church, it also means so much more to Deborah and Clive. They both have seen it as a Community Event and rightly so.

Cakes and tea are served and many locals kindly donate homemade cakes. People visit from all over the parish and further afield. Sadly for us, this year's was their last.

The amount of effort and dedication shown by this modest couple has been incredible. Hard work, whilst rewarding, it has now come time for them to step down.

Somehow we don't think they will be putting their feet up for long. A huge thank you from all of us.

Archaeological Excavations at Soulton Hall

May and June 2023 saw the fourth season of archaeological excavations at Soulton Hall, led by Dig Ventures.

This research compliments ongoing scholarship by James D. Wenn on the thousand year story of the Manor of Soulton. Previous seasons have looked at the mound near Soulton Bridge which is now confirmed to be a small chivalric castle-type structure which was established by the mid 1200s and was in occupation until around 1400, when the focus of the occupation shifted to the present home site of the Manor.

This year's work sought to prove some theories about the sixteenth century phases of Soulton's story, when it was the Shropshire headquarters of the important Tudor statesman Sir Rowland Hill.

In returning to the investigations this Summer, it is understood that Soulton Hall was built in an elaborate set of codes that draw on the ideas in scripture, humanism, and classical philosophy. For instance, the view of the hall from the bridge with the two tower-like projections is intended to evoke Solomon's Temple, while the precinct being the same size as the Telesterion of Ancient Greece is consciously suggesting Eleusis, where the Athenians performed the senior mysteries of the classical world.

These allusions to different aspects in the architectural project go on and on and are very sophisticated. Though outside the scope of this article, they are covered in a James D Wenn's forthcoming book *Stones of the Magi* (Canalside Press), as well as in a lecture available on Youtube under the title *Garnet as Emblem of Goodness* | *Philosophical architecture from Henry III to George III*

Rowland Hill clearly incorporated the landscape beyond Soulton Hall for these architectural games, and the team were looking into how this might have worked and what remained.

The outputs of this year's work appear to confirm;

- 1) that there was a large lawn down the currently lost axis addressing the rising sun on Easter morning;
- 2) that the mound of the lost castle was recruited in some form in this landscape in the 1500s; and
- 3) that there may have been a very large yard between the current hall (Hill's elite accommodation block of the wider palace he built which has since been moated and lost) and what is now Soulton Road.

These developments support the theory that Hill was staging theatre just outside Wem, the generation before Shakespeare – which is profoundly important to our understanding of how the renaissance happened in England. Tantalisingly, the dancing pavement behind Soulton Hall begins to look like it shows the lost choreography for the dance performed at the end of *As You Like It*.

There is a need for further research in several disciplines to get an appropriately deep understanding of the full extent of what was happening at Soulton in these times. It is, however, very exciting in terms of what may be able to be unlocked for our county in terms of heritage and cultural led regeneration and hence economic opportunities for Wem Rural.

The Wem P3 (Parish Paths Partnership) Group

Those who like walking in the countryside around Wem Town and Rural parishes may have noticed some improvements to the paths and infrastructure recently. This is due in main to the Wem P3 group where P3 stands for Parish Paths Partnership. We are a small group of #volunteers who are supported by Shropshire Council to help maintain the local footpaths. The Council supplies the stiles, field gates, posts, railings and other hardware along with a small annual budget to cover sundries such as #replacement tools, nails, fuel for strimmers etc. In addition they also organize training days for power tool usage and we are also covered by their insurance whilst working provided of course, that we have followed the correct procedures.

Many years ago there was a series of Wem Walks published in the form of a small booklet which is now out of print. A lot of these circular walks started in Wem Town and then went into Wem Rural where the majority of the footpaths are situated. However time, nature and a few inconsiderate land owners have taken a toll on the footpaths so that most if not all now require some degree of maintenance. This is where the Wem P3 and Shropshire Council's Rights of Way department come in.

Over the past couple of years we have been slowly but steadily trying to clear and repair the walks with a view to signing them correctly and then publishing them. As mentioned before the original walks were published in a booklet but things have moved on somewhat now.

Therefore a decision has been made on financial grounds to initially try to publish them in future on the Wem Town and Wem Rural Council websites. There they can either be loaded onto a smartphone or printed off directly. This may change in the future if / when funding becomes available and walk leaflets can be produced.

A good example of one of our walks is that of WW6 (Wem Walk 6). This starts in the Co-Op car park and goes to Alderley Lane via Church Lane. 3 years ago it was impossible to get onto Alderley Lane via the footpath as it was completely blocked by brambles. These have now been cleared and 2 gates fitted. Further on the track through Soulton Woods was completely impassable but this has now been cleared and is now well used. Further on a small rotten bridge over a brook has been completely replaced. The route now takes us into Whixhill and then back into Lee Brockhurst where it goes up the 100 Steps. Now this was a challenge in the mud. We have tried to stabilise the rocks to a greater degree along with repairing the handrail and improving the stile at the bottom.

Although the steps are now much safer care should be taken especially in the winter as they do get very slippery which is a situation that we as a group cannot do anything about. However, this walk of about 7 miles is now a going concern and if it continues to be used will be kept naturally clear.

Helping to combat speeding in Northwood

The most lethal roads in Britain are rural roads with a 60mph speed limit, with **514 deaths in 2021** according to figures from the Department of Transport. So traffic passing through villages like Northwood, where 60mph changes to 30mph, needs monitoring and drivers need to observe the 30mph limit for the safety of all road users.

This is why Parish Councillor John Britton has been talking to local residents and handing out wheelie bin speeding stickers in Northwood to help combat drivers speeding over the 30mph limit.

Parish Councillor Britton is also one of the 8 volunteers of SpeedWatch in Northwood that monitors traffic and report any violations to West Mercia Police, who then issue a warning to drivers.

The Biodiversity of Ragwort!

At the time of writing, verges, waste ground and some fields are lit up by the bright yellow flowers of Ragwort - *Senecio jacobea* to give its biological name. There is no doubt that Ragwort is a serious enemy to farming and livestock. It is a native species of the British Isles and is a specified weed under the Weeds Act 1959. It contains toxins which can have debilitating or fatal consequences if eaten by horses and other grazing animals. DEFRA states that it is specifically covered by the Ragwort Control Act 2003. Although this code does not seek to eradicate it, it is necessary to prevent its spread as it presents a high risk of poisoning horses and livestock or spreading to fields used for the production of forage.

But does Ragwort have any saving graces? Yes, because it is very important for wildlife in the UK. Its ecological importance is considered significant for biodiversity because it provides a home and food source to at least 77 insect species. Thirty of these species of invertebrate use it exclusively as their food source, and there are another 22 species where Ragwort forms a significant part of their diet.



The most common of those totally reliant species on Ragwort for their survival is the Cinnabar moth. The Cinnabar is a United Kingdom Biodiversity Action Plan Species, its status described as "common and widespread, but rapidly declining". You may well have noticed groups of the orange and black caterpillars, and maybe even seen the adult moth, as shown in the photographs. Other species feeding on Ragwort are named in the UK Biodiversity Action Plan, and include some that are defined as Nationally Scarce.




To help support local businesses Wem Rural Parish Council, along with Wem Town Council and Wem Town Hall is holding a Business Networking Event.
